MAYOR'S REPORT

Mayor's Report Condolences

On behalf of the RMOW and Council, Mayor Jack Crompton offered his sincere condolences to the family and friends of Louise Buchholz who passed away in December, 2018. Louise Buchholz was a committed member of the Whistler community. She selflessly dedicated her time as co-chair the

Whistler Remembrance Day Service for more than 20 years, sat on the Whistler Museum Board, volunteered at many local sports organizations, and within the Whistler Fire Rescue Service community where her husband Brian was a long-time member. Louise Buchholz's friends have shared that: "the outpouring of love and support have shown just how deeply Louise impacted so many in Whistler and far, far beyond."

Whistler.ca breach

The RMOW's municipal website whistler.ca was subject to a security breach. The cause of the breach has been found and resolved. It appears the purpose of the attack was to re-direct people to websites for the purposes of product marketing. Personal information collected through forms on the website may also have been vulnerable. However, it doesn't appear that the hackers were looking for personal data. Steps are being taken to inform people whose personal information was stored on the website. There were no social security numbers or credit card details involved. Municipal staff are directly calling or emailing as many people as possible who may be impacted so they can take any necessary action. The privacy of people's personal information is a top priority for the RMOW and the current response reflects this commitment. Snow clearing efforts during winter storm

Last week, Whistler experienced one of the largest snow and rain falls in the valley in one day that many can remember. Snow clearing teams worked hard, and even though the conditions were challenging, access into the Village via road and transit was maintained. Footpaths and the Valley Trail in the Village were also kept clear, amid heavy snow fall throughout the day. Mayor Jack Crompton thanked all the crews who worked to keep Whistler's roads and the Village clear and safe during the storm.

Lost Lake Nordic Trails open

Lost Lake Nordic Trails opened on December 21, 2018 for the winter season. All 25 kilometres of cross country skiing and 15 kilometres of snowshoeing trails are available to enjoy. Returning this season is the 50 per cent discount on tickets for night skiing on Monday and Thursday evenings. Season passes are also available for purchase at Meadow Park Sports Centre. Christmas Trees to Nesters Depot

Whistler's waste depots at Nesters and Function Junction are accepting real Christmas trees until January 13, 2019. The service was expanded over the Christmas period to accept Christmas trees to make it easy to dispose of them properly, and remove fire risks in summer months. The Depots are open from 7 a.m. to 7 p.m., and people are reminded to remove all lights, tinsel, and decorations first.
