PUBLIC QUESTION AND ANSWER PERIOD

Steve Neal 5726 Alta Lake Road Re: OCP – Schedule B

Mr. Neal noted that his question was regarding Schedule B of the OCP with specific reference to a map showing an area of around 50 acres above the Brio neighbourhood that looked like it was slated for development. He added that he had missed that there had been an opportunity to submit feedback.

What is the development slated for?

Will there be an opportunity for more public debate?

General Manager of Resort Experience J. Jansen stated that the Schedule B is a plan that would include the various Option Sites identified in the Whistler Blackcomb Master Plan.

Mayor N. Wilhelm-Morden added that Whistler Blackcomb's Master Plan has been incorporated into the OCP, but that doesn't mean it is approved, and any development would go through the zoning process, and the regular approvals process, which would allow for opportunities for public feedback.

Water Main Break

A presentation was given by General Manager of Infrastructure Services James Hallisey and Utilities Group Manager Gillian Woodward regarding the water main break.

MAYOR'S REPORT

Mayor's Report

Water Main Break on Lorimer Road

Since the water main break on August 14, 2018 on Lorimer Road, there have been two other water main break incidents. These were unrelated and were unique breaks occurring on different pipe sections with different ages and pipe materials. Upgrades to Whistler's water infrastructure is being actioned via the infrastructure asset management plans dated 2014 or later, however unexpected breaks can still occur.

Valley Trail Closure between Rainbow Park and Lorimer Road

The Valley Trail will be closed between Rainbow Park and Lorimer Road from September 4 to 21, 2018. The closure will be on weekdays between 6 a.m. and 5 p.m. The closure is necessary to upgrade municipal water supply to meet current and future water demands. Detour routes have been set up. Rainbow Park and the River of Golden Dreams remain open throughout construction. Mayor Nancy Wilhelm-Morden thanked the community for their cooperation and noted that a map of the detour and further closure details can be seen on the website whistler.ca/ValleyTrail.

Wayside Park Beach Reopened

Wayside Park Beach has reopened for swimming. The Resort Municipality of Whistler has been monitoring the water quality closely following high E.coli levels. The E.coli levels have now dropped below measureable levels. The source of the contamination is still unknown and municipal staff are investigating the possible causes.

River of Golden Dreams Closure

A section of the River of Golden Dreams has been temporarily closed due to low water levels.

There is no access between Alta Lake fish weir to the CN rail bridge. The closure is to protect the rainbow trout and kokanee salmon in the area. Boaters are asked to launch from the portage trail below the lower railway bridge accessible from the end of Lorimer Road.

RBC GranFondo Whistler

The ninth annual RBC GranFondo Whistler cycling race is taking place on Saturday, September 8, 2018. Highway 99 will remain open, but traffic will be delayed between the hours of 5:30 a.m. and 4:30 p.m. There will be additional delays within Whistler entering and exiting the east side of Highway 99 from Cheakamus Crossing to Village

Gate Boulevard. Day Lot 4 will be closed on Friday, September 7 and Saturday, September 8, 2018. Residents and visitors are encouraged to take transit, walk, or bike. Mayor Nancy Wilhelm-Morden reminded the public that Whistler Transit is free of charge all weekend and will operate with modified routes south of Whistler Village. A GranFondo Event Shuttle will also operate from Whistler Creekside to Whistler Village between 9 a.m. and 4 p.m. Spectators are encouraged to cheer on riders at the finish line on Blackcomb Way, from 10 a.m. Everyone is invited to join in the celebrations at Whistler Olympic Plaza and to watch the Nearly Neil and The Solitary Band performance at 1:45 p.m.

Community Chipper Day September 9 to October 14, 2018

The Resort Municipality of Whistler is working with residents to FireSmart their homes. Reducing the amount of fuel for wildfires on your property is the most significant action you can take to reduce the impact of wildfires. To help, the Resort Municipality of Whistler is putting on six FireSmart Community Chipper Days, planned on Sundays between September 9 and October 14, 2018. Mayor Nancy Wilhelm-Morden encouraged residents to work with neighbours to prune and remove brush and excess branches from their properties. The FireSmart crew will come and collect the brush and tree debris free of charge. There is limited capacity for each day and booking is advance is required. UBCM in Whistler September 10 to 14, 2018

The Union of BC Municipalities (UBCM) convenes for the Annual Conference in Whistler from September 10 to 14, 2018. Whistler is proud to be hosting this event at the Whistler Conference Centre and approximately 2,000 delegates are expected. The UBCM Conference offers an annual opportunity for municipal delegates to come together and discuss areas of shared interests, and for municipalities to meet with provincial ministers and staff. The municipality has confirmed meetings with nine provincial ministers on topics ranging from housing and regional transit, to FireSmart and tourism funding. Mayor Nancy Wilhelm-Morden stated that she will be reporting on these meetings after the convention and she will also be taking the opportunity to meet other Mayors at the Mayors' Caucus to discuss common goals and learn from each other's experiences. The Resort Municipality of Whistler looks forward to welcoming the delegates.

Rogers Hometown Hockey Visits Whistler February 2019

The Resort Municipality of Whistler was excited to announce last week that the Rogers Hometown Hockey Tour will be visiting Whistler next year. Whistler will be one of 24 community stops across Canada and the Tour will visit Whistler on February 9 and 10, 2019. Mayor Nancy Wilhelm-Morden noted that this is a wonderful opportunity to showcase Whistler and our local hockey players and fans. There will be updates about community events for the tour in the New Year.

District Energy System - Cheakamus Crossing

Earlier today in the Closed Council Meeting, Council once again discussed the District Energy System-connected home heating systems associated with the 174 Whistler Development Corporation-constructed units in Cheakamus Crossing. Further to the steps already taken to provide these property owners with ongoing information, maintenance support and options, Council recognizes that some residents are still having issues with their in-home systems and are seeking further information,

guidance and assistance. Council discussed in both the August 14 and September 4, 2018 Closed Council Meetings several potential measures that will seek to help:

- ensure that important annual maintenance is put into place;
- address systems that have exhibited problematic failure; and
- help those interested in opting out of the system.

Council has directed staff to further investigate these measures, and steps around implementation are anticipated to be shared publicly and with property owners in September as Mayor Nancy Wilhelm-Morden noted in her report at the August 14, 2018 Council Meeting.

CKNW Radio Show

Mayor Nancy Wilhelm-Morden noted that she will be co-hosting on the CKNW radio show from 8 a.m. to 10 a.m. on September 5, 2018 and will be talking about all things Whistler.

Zero Waste Council

Councillor Sue Maxwell noted that the Zero Waste Council held a Webinar in August regarding the circular economy through procurement from a municipal perspective. Councillor Maxwell noted that it was interesting to hear how the City of Toronto was leveraging money to achieve benefits, and meaningful changes.
