MAYOR'S REPORT

Mayor Wilhelm-Morden reported that the spring and summer banner design competition concluded last week and the proposal by Elisa Dejong of Ridge Studio was selected. Her proposal is called Stimulating the Senses. Dejong's banner set will be installed in the spring and summer of 2013 and 2014.

Mayor Wilhelm-Morden reported that Whistler will once again participate in the Mayor's Poetry Challenge. Last year cities and towns across Canada participated. This will be the fifth year the Poet's Pause competition will also be staged. The selected poems will be read at a regularly scheduled Council meeting and a reading ceremony at the Poet's Pause sculpture sites in Alta Lake Park. The deadline for entries is 3:00 p.m. on Monday, April 8, 2013. Visit the municipal website for the Terms of Reference as well as other details of these two competitions.

Mayor Wilhelm-Morden reported that the Recreation Program Guide for spring and summer 2013 will be available online Friday, March 8, 2013. Registration will start on March 17, 2013, at 12:01 a.m. for Whistler residents. Make sure you have a PLAY registration number before you go online. Non-residents will have the opportunity to register a week later starting on March 24, 2013, at 12:01 a.m.

Mayor Wilhelm-Morden reported that the RMOW is seeking a member to serve on the Forest and Wildland Advisory Committee. Candidates should have a background in forestry, ecology, backcountry recreation or resource management, and knowledge of the Whistler area. Information can be sent to Heather Beresford via email at hberesford@whistler.ca or can be dropped off at Municipal Hall before 4:30 p.m. on March 21, 2013.

Mayor Wilhelm-Morden invited residents and visitors to Whistler Olympic Plaza this evening from 9:00 to 10:00 p.m.to check out an outdoor sledge hockey final game being played by injured Allied soldiers who have been here all week for a camp hosted by the Whistler Adaptive Sports Program.

The camp is a partnership between the Canadian Paralympic Committee and the Department of National Defense's 'Soldier On' program. While in Whistler, camp participants have had the opportunity to experience a few of the 2010 Olympic and Paralympic Winter Games legacies by taking part in alpine skiing, snowboarding, curling and sledge hockey. As part of the weeklong experience, the soldiers were divided into groups of 10 to learn how to play sledge hockey at the Meadow Park Sports Centre. Mayor Wilhelm-Morden will be meeting the group for dinner on Thursday night with a number of other dignitaries.

Mayor Wilhelm-Morden reported that the Learning and Education Strategy Task Force is holding an Open House on April 4, 2013, at the Whistler Conference Centre from 5:00 p.m. until 8:00 p.m. It will be an opportunity for the task force to share with the community what they've learned via storyboard and a short presentation, and will be seeking consultation with the community at that time.

Mayor Wilhelm-Morden reported that Edward Dangerfield has been appointed to the Liquor License Advisory Committee for a two-year term representing the restaurant sector. She thanked the former restaurant representative for the committee, Jay Pare, for his service.

Mayor Wilhelm-Morden reported that for many the years municipality has recognized those volunteers who sat on various committees and task forces by hosting a dinner and asking those people to attend. Attendance has been dropping at that dinner over the years, so this year a different approach has been taken and thank you notes were sent to each of the volunteers. On the volunteers behalf, the funds that would have normally been spent on the dinner were added to the Community Enrichment Program. She thanked all of those who have assisted Council in the past year. Council relies on the committees, commissions, and task forces. Mayor Wilhelm-Morden reported that Council is looking at other ways to recognize volunteers in the future.

Mayor Wilhelm-Morden reported that the RMOW has extended its amnesty parking program to March 15, 2013. Outstanding parking tickets can be settled for 50 per cent off the amount oweing. So far, 331 tickets have been paid and \$5 from each ticket will be donated to Whistler Animals Galore Society (WAG). So far, \$1,655 has been collected for WAG through this program.
