ALTERNATIVE MUNCIPAL TAX COLLECTION SCHEME AMENDMENT BYLAW NO. 2355, 2022

A BYLAW TO AMEND THE ALTERNATIVE MUNICIPAL TAX COLLECTION SCHEME BYLAW NO. 2282, 2020

WHEREAS the Council of the Resort Municipality of Whistler (RMOW) has adopted the "Alternative Municipal Tax Collection Scheme Bylaw No. 2282, 2020" (Bylaw);

AND WHEREAS the Council of the RMOW is authorized to establish one or more dates on which all or part of the property taxes are due; and to establish penalties and interest to be applied in relation to payment made after a tax due date.

NOW THEREFORE the Council of the Resort Municipality of Whistler in open meeting assembled, **ENACTS AS FOLLOWS**:

CITATION

1. This Bylaw may be cited for all purposes as the "Alternative Municipal Tax Collection Scheme Amendment Bylaw No. 2355, 2022".

AMENDMENTS

- 2. Section 3 of the Bylaw is amended by replacing the phrase "July 30" with the phrase "July 2".
- 3. Section 4 of the Bylaw is amended by replacing the phrase "July 13" with the phrase "June 15".
- 4. Section 5 of the Bylaw is amended to replace the phrase "July 13" with the phrase "June 15".
- 5. Section 7 of the Bylaw is amended to strike out the passage "a penalty of ten per cent (10%) on any balance owing after September 30" and replace it with the passage "a penalty equal to five per cent (5%) of the portion that remains unpaid after July 2 of the year".
- 6. A new Section 8 of the Bylaw is created to add the passage "If all or part of the property taxes for the current taxation year, in respect of each parcel of land and its improvements shown on the tax roll, remain unpaid after September 15, the Collector must add to the unpaid balance an additional penalty equal to 5% of the portion of current year's taxes that remains unpaid (this penalty will not be applied to the penalty assessed in Section 7) on the following day.
- 7. Section 8 of the Bylaw to be renumbered as Section 9.
