4. PUBLIC QUESTION AND ANSWER PERIOD

Questions were submitted in advance of the Meeting by email.

Brendan Ladner, 131-6117 Eagle Drive

Why are 8 year girls not biking themselves to school here in Whistler?

Mayor J. Crompton explained kids in Whistler are very attached to their bikes and we have lots of cyclists using the trails and riding to school.

Bruce Green, 5205 Jordan Lane

1. How can Council effectively evaluate whether the Private Sector Housing Guidelines are being met by any given proposal if they do not have access to the *pro forma*?

Mayor J. Crompton advised that the RMOW hired individual third party to review the confidential pro formas and provide this information to staff who then provide to Council in their staff reports.

2. Does Council intend to require updated, current *pro formas* for compliance with Private Sector Housing Guidelines projects that are pending, such as 5298 Alta Lake Road?

Mayor J. Crompton advised that Council is within its rights to ask for that info and can do so.

Brandon Green, 5205 Jordan Lane

Q 1: What was Council's intent in dropping the requirement that employee housing proposals be 100% Whistler Housing Authority (WHA) and instead allowing for mixed market/WHA proposals?

Mayor J. Crompton noted Council is sensitive to neighbourhoods but needs to deliver employee housing in Whistler.

Q 2: How many new applications for such mixed projects have been submitted in the three years since these guidelines were revised?

- Mayor J. Crompton advised no new mixed project applications have been submitted. The RMOW is working hard processing applications that are already in the pipe.
- Q 3: Would Council agree that the revised policy has so far failed in its intent, and that its main effect has been to permit RZ1157 to move forward?
- Mayor J. Crompton noted the revised policy is delivering more housing. There is more to do, but it is meeting Council's intentions.
- Q 4: Why is staff advising Council to use this other, lower standard, rather than the standard set out in the Guidelines and endorsed by this Council?
- Mayor J. Crompton explained this site (5298 Alta Lake Road) had base zoning, it had a zoning already when the application was submitted and Council must consider existing zoning.

Questions were asked during the Meeting.

John Sinclair, 1500 Spring Creek

- J. Sinclair asked if the process for submitting correspondence to Council has changed?
- Mayor J. Crompton advised that as a COVID-19 measure, Council have allowed members of the public to pre-submit questions to Council instead of having to attend the meeting in person.
- J. Sinclair asked at what point does the action happen for council correspondence?
- Mayor J. Crompton advised that it depends on the type of correspondence. Correspondence follows normal process; is either received by Council or is received and referred to staff for consideration. It depends on what is being requested and what is required.
- J. Sinclair asked if there has been any further consideration of the traffic study on the Alta Lake Road traffic light, intersecting at Highway 99?

General Manager of Infrastructure Services J. Hallisey advised no further studies have been done. Mayor J. Crompton advised it was studied in 2021 and will be considered as part of the project.

Danny Mason, Tynebridge Lane

- D. Mason asked what is Council's position on a municipal vacancy tax to combat the homeless crisis?
- Mayor J. Crompton and General Manager of Corporate and Community Services T. Battiston explained that these types of taxes are either federal or provincial and as a result any revenue flows directly to that level of government and not the municipality.
- D. Mason asked if there was a willingness from Council to bring this up at UBCM?
- Mayor J. Crompton reiterated that because any revenue would flow directly to Victoria, there wasn't an appetite for this at this time.
- D. Mason asked when can residents expect an update for the cash in lieu procedure?
- Chief Administrative Officer V. Cullen advised that this item is on the Planning team's work plan but that it won't come up until later in the year after the election.

D. Mason asked when the bus shelter construction will start?

Mayor J. Crompton expressed his frustration that the bus strike is on going and urged everyone to get back to the bargaining table to resolve the issues.

General Manager of Infrastructure Services J. Hallisey advised that with respect to the bus shelter project, the team is a week away from awarding the tender for that.

D. Mason asked about what happens to the money that the community pays BC Transit during the strike.

Mayor J. Crompton advised that the RMOW is not being charged the full amount during the strike. He also sincerely hopes that when the strike is over, we can grown the transit service.
