Attn Mayor, Council and Staff,

Please accept this email on behalf of the Sea to Sky Chapter of the Canadian Home Builders Association. It's a bit short notice as we only saw the proposed revision today.

We have reviewed the revised staff proposal and would like to add some additional comments for your consideration if possible.

1. The CHBA can support start times of 9am on Sundays and Statutory Holidays. This seems like it could be a reasonable compromise for the community wishes to have some quieter hours.
2. We note that the revised staff proposal had put the Saturday start time at 9am. We would strongly suggest that you consider rejecting this and align the start time with the Monday to Friday start times. The Cheakamus Crossing project is a good example of why additional time constraints will only increase construction costs. Projects like this need to work 7 days a week to complete their work on time in an efficient manner. Starting at 9am on a Saturday is inefficient and seems unnecessary in a town where we all work varied schedules.
3. We previously requested a regular hours start time of 7 am in our letter to you. Most municipalities that we looked at start at 7am and we see no reason why this community should be treated differently. But we would be ok with a 7:30am start time if 7am is not deemed to be desired by council.
