



Training Proposal to the Resort Municipality of Whistler

This proposal outlines how Passive House Canada (PHC) and the Resort Municipality of Whistler will cooperate in providing PHC education course delivery. This Agreement expires as soon as the deliveries are completed.

Passive House Canada

PHC is a not-for-profit corporation incorporated under the laws of Canada to support the design and construction of buildings to the International Passive House standard. The organization provides Passive House high-performance building training and delivers examinations for candidates to achieve the Passive House Designer/Consultant certification as part of its mandate. PHC advocates with governments and industry for the adoption of Passive House new build and retrofit standards as an important way to reduce Canada's Greenhouse Gas Emissions and provide healthy, comfortable, and durable buildings.

Regarding

The deliveries of the Introduction to Passive House High Performance Buildings (90 Course) – 8 hours course.

Responsibilities

It is the responsibility of Passive House Canada to deliver the courses online.

PHC will provide course materials digitally. The City of Whistler may choose to provide printed manuals for students.

PHC will provide course recordings to the registrants for 30 days (only people who are registered for the course will have access to the recordings).

PHC will provide Certified Passive House Designers/Consultants instructors with field experience and teaching experience.

All the content presented is Passive House Canada's property and shall not be reproduced without formal consent.





Delivery

Courses will be delivered LIVE online using zoom.

PHC will provide the zoom meetings.

The Resort Municipality of Whistler will be responsible to send the participants list in advance, limiting the class to 20 participants.

Course Descriptions & Schedule

Course description

An Introduction to the Passive House High Performance Buildings provides an overview of the core principles of Passive House design and building energy efficiency regulations in Canada. The course also covers the history of energy efficient buildings, energy consumption data and environmental impact, case studies and the economics of creating high performance buildings.

Recommended for

Anyone wishing to understand the basics of Passive House high performance buildings, including:

 Homeowners, developers, project coordinators, realtors, subcontractors and component suppliers, architects, engineers, architectural technologists and other design professionals.

Learning outcomes

- Understanding Passive House principles
- insulation and airtightness design and construction techniques
- Thermal bridging basic concept
- Window placement and construction, window components and efficiency
- Ventilation system in a Passive House building
- Economics of Passive House design and construction
- · Case studies.





Delivery Schedule:
