PARKING AND TRAFFIC AMENDMENT BYLAW (COMMERCIAL VEHICLES) NO. 2363, 2022

A BYLAW TO AMEND "PARKING AND TRAFFIC BYLAW NO. 2177, 2018" AND "RESORT MUNICIPALITY OF WHISTLER BYLAW NOTICE ENFORCEMENT BYLAW NO. 2174, 2018".

WHEREAS the Council of the Resort Municipality of Whistler has adopted "Parking and Traffic Bylaw No. 2177, 2018" and "Resort Municipality of Whistler Bylaw Notice Enforcement Bylaw No. 2174, 2018";

AND WHEREAS the Council of the Resort Municipality of Whistler deems it expedient to modify parking provisions applicable to vehicles parked for commercial purposes;

AND WHEREAS the Council of the Resort Municipality of Whistler deems it necessary and expedient to amend "Parking and Traffic Bylaw No. 2177, 2018" and to amend offences designated under "Resort Municipality of Whistler Bylaw Notice Enforcement Bylaw No. 2174, 2018";

NOW THEREFORE the Council of the Resort Municipality of Whistler, in open meeting assembled, **ENACTS AS FOLLOWS**:

CITATION

1. This Bylaw may be cited for all purposes as the "Parking and Traffic Amendment Bylaw (Commercial Vehicles), No. 2363, 2022".

AMENDMENTS

- 2. Parking and Traffic Bylaw No. 2177, 2018 (Parking bylaw) is amended by:
 - (a) deleting the definition of "Commercial vehicle" in section 4.1 and replacing it with the following:

"Commercial vehicle" means:

- (a) any vehicle defined as a commercial vehicle in section 1 of the *Commercial Transport Act*, as amended from time to time;
- (b) any vehicle used for the collection, delivery or transportation of goods in the course of a business; or
- (c) any vehicle used in the course of business of a tradesperson;
- (b) replacing "commercial vehicle" with "Commercial vehicle" wherever it is written in the Parking bylaw;
- (c) deleting the definition of "Commercial parking decal" in section 4.1 and replacing it with the following:

- "Commercial parking decal" means a decal issued for a vehicle used in the course of the collection, delivery or transportation of goods in the course of a business:
- (d) adding a new definition in alphabetical order of "Service parking decal" to section 4.1 as follows:
 - "Service parking decal" means a commercial parking decal issued for a vehicle used in the course of business of a tradesperson;
- (e) Deleting "commercial vehicle decal" and replacing with "Commercial parking decal" wherever it is written in the Parking bylaw;
- (f) deleting subsection 12.2(a) and replacing it with the following:
 - (a) is displaying a valid Service parking decal and is parked on the side of the highway adjacent to even-numbered buildings for a period no longer than 30 minutes; or;
- (g) Amending section 12.3 to add the word "valid" between the words "displaying a" and "commercial parking decal";
- (h) deleting subsection 12.4(c) and replacing it with the following:
 - (c) confirmation of whether or not the vehicle meets the definition of commercial vehicle:
- (i) deleting subsection 12.4(e) and replacing it with the following:
 - (e) payment of a \$40.00 processing fee per vehicle up to a maximum processing fee of \$400.00.
- (g) deleting subsections 8.1(o)(iii) and 8.1(o)(iv) and replacing them with the following:
 - iii. displaying a sign or using the vehicle to advertise a business or service; or
 - iv. selling or distributing goods or providing a service, including selling flowers, fruit, vegetables or seafood.
- 3. "Resort Municipality of Whistler Bylaw Notice Enforcement Bylaw No. 2174, 2018" is amended by deleting the following rows from Schedule A:
