Upon review of bids, Wilco Civil Inc. was the lowest compliant bidder at \$3,306,618 including all optional items and cash allowances (not including GST). We recommended a post-tender addendum process take place with Wilco to reduce quantities and scope to achieve the desired budget. Two rounds of post-tender addendums were issued on May 1<sup>st</sup> and May 4<sup>th</sup>, 2023 respectively.

The revised scope of work reduces quantities of paving and planting, and includes the optional shade sail, picnic tables and benches, alpine chairs, and a reduced quantity of chaises.

The resulting price was **\$2,738,910.50** + taxes leaving a total of \$196,443.50 or 6.69% for contingencies during the construction process (based on the communicated budget of \$2,935,354 available for this project (not including GST).

To advance this project to construction we recommend a contract award to Wilco Civil inc.

Connect will proceed with producing Issue for Construction drawings and specifications. Any additional changes to the plans would be captured through a change order process that would be a revision to the contract amount noted above.
