PRESENTATIONS/DELEGATIONS

Updates

Conservation Officer Service (COS)

A presentation by B. Mueller was given regarding the Conservation Officer Service activities and a discussion was held

- COS has received a couple sightings of bears.
- One or two bears are active in Whistler Cay/ Nesters and they made some appearances in Whistler Village.
- One bear has attempted to access a BBQ.

RMOW Bylaw Services

A presentation by J. Pineda was given regarding RMOW Bylaw Services activities and a discussion was held.

- Bylaw addressed attractant issue: bear attracted to bird feeder in Barnfield Resident was surprised as they only use it in winter because they thought bears had hibernated. This year bears are still around and have not yet hibernated—potential need for education around non-hibernating bears.
- Two commercial properties had issues with overflowing garbage in the villas and benchlands. Bylaw received compliance from business owners when working with them, however, issues remain with staff being complacent.

Whistler Wildlife Protection Group

A presentation by I. Minic-Lukac was given regarding Whistler Wildlife Protection Group activities and a discussion was held.

- No reports of human wildlife conflict in Whistler neighborhoods
- The Group is looking for a few volunteers to help door to door for May and June. If new volunteers are recruited, an information session by COS is requested.

T. Green

A discussion by T. Green was held.

- T. Green indicated requested a social media post be published to educate public about how some bears do not hibernate and to remind them to continue securing attractants.
- T. Green informed that Steve Rochetta was willing to present on Grizzly bears in Callaghan.

A. DeJong

A discussion by A. DeJong was held.

- DeJong inquired about health of bears and possible reasons behind why bears this winter are not hibernating.
- Recommended a comment to council that our WBAC work is not just aimed at reducing human-bear conflict but to continually support community goals to protect bears and work towards the preservation of bear lives in Whistler.

TOR

T. Schaufele presented review of Terms of Reference. The following changes to the TOR were agreed upon:

- Adjust meeting commitment requirement to must make 2/3 of meeting so that committee can ensure communication between bylaw and RCMP stay open
- Alter verbiage of point 6 in the TOR to include language around the protection of bears and the preservation of bear lives.
