- Ensure the following additional green building features are included:
  - a. Provision of electrical conduit with access to a circuit (i.e., EV-ready) for all residential parking stalls; and
  - b. Building energy efficiency and performance to meet or exceed BC Energy Step Code Step 3 with Strong Carbon Performance, as defined through the BC Energy Step Code, Zero Carbon Step Code and as required by the RMOW "Building and Plumbing Bylaw No. 1617, 2002", as of January 1, 2024.
