Bylaw and Impound Services

- Whistler Animals Galore Society (WAG) provides core community services that includes responding to complaints on animal control and bylaw matters such as dog licenses, dogs off leash complaints, lost and found animals, animal cruelty complaints, dogs left in hot vehicles complaints.
- WAG shelters lost and stray animals, we care for these animals until we can reunite them with their families.

- WAG takes in animals needing emergency boarding while their families deal with difficult life events such as evacuations from their home, housing challenges, mental health emergencies or injuries.
- Through this service WAG helps maintain a safe and enjoyable community by encouraging compliance with the RMOW Animal Responsibility Bylaw.

Rehoming and Rescuing

- WAG contributes to important life decisions made by community members in a meaningful, respectful and supportive way through our Adoption and Surrender programs.
- Our adoption program is a thorough approach that is unique to the individual needs of each animal and home. We work hard to set every animal adoption up for success with pre and post adoption counselling.
- The decision to surrender an animal is never one that is made lightly. We offer counseling during this difficult decision and help the family find the best decision for their animal based on their unique situation.
- Through this service we are enhancing the quality of life for all residents, two and four legged.

Outreach

- In partnership with the Lil'wat Nation WAG hosts offsite Animal Wellness Clinics which help families who cannot afford regular veterinary care that includes spay and neuter surgeries, parasite control and regular veterinary exams.
- WAG's Animal Food Bank distributes between 100-200 bags of dog and cat food to remote communities every year. WAG further distributes supplies such as dog beds, dog houses (that provide critical shelter for dogs living outdoors), collars, harnesses, and toys.
- We work together with the Lil'wat Nation in the spirit of reconciliation and cooperation to achieve the collective goal of enriching community life through animal welfare and education.

Year to Date

- WAG has successfully completed two Animal Wellness clinics within the Lil'wat Nation and have two more planned for the upcoming Fall.
- We've administered vaccinations to 51 dogs, alongside providing vouchers for low-cost spaying and neutering.
- WAG provides this important animal welfare in partnership and collaboration with local veterinarians, Dr. Sturgess and Dr. White from the Pemberton Veterinary Hospital.
- Through our FANS (Financial Assistance with Neutering and Spaying) program which provides for low-cost spaying and neutering for pet guardians, we have successfully spayed and neutered 24 dogs and cats this year to date. This initiative aims to assist families in keeping their pets while mitigating the issue of unwanted litters and helping control the ever-increasing animal population.

Community Engagement

• WAG provides meaningful community engagement opportunities through our volunteer and foster programs and community events. These programs greatly enrich the lives of community members who learn about animal behaviour, welfare, sheltering, event planning, training, disease prevention, and most importantly empathy and compassion towards animals.

- Volunteering with WAG is a powerful way to find true connection, improve mental wellness and foster one's community involvement.
- Our foster program allows people who are only here temporarily have the company of an animal and feel the incredible emotional reward that comes with helping homeless animals.
- WAG partners with several local businesses to raise animal welfare awareness and bring the community together through social events and fundraising initiatives.

Recent events include:

- Shelter Tours open days to the public to learn about our important community programs and services.
- WAG WOOF WATER in partnership with Arts Whistler, WAG presented the 2nd Annual Dock Dog Jumping Competition at Art on the Lake.
- Pups + Pints in partnership with Coast Mountain Brewery we hosted the annual event for dogs and humans to raise awareness about our Critical Care Program.
- Patio parties with the dogs! As Whistler's local restaurants become more pet friendly WAG has partnered with multiple local business such as Stinky's on the Stroll, RMU and the Fitz Pub and more to help open and celebrate their pet friendly patios!

Upcoming events include:

- kindergarten class visit. This wonderful class raised funds for WAG and in October we will bring a WAG animal to their class to educate about animal welfare and shelters.
- Pet Photos with Santa A family favorite event!
- We are excited to be bringing our K9 Wine and Dine Gala back in 2024!

WAG is uniquely positioned to deliver the services mentioned above for many reasons, including:

Professional Development

Our staff is experienced and knowledgeable in animal training, rehabilitation, health and welfare. WAG continues staff education and professional development with the following courses:

- o Indigenous Awareness
- o The Academy for Dog Trainers
- Karen Pryor Shelter Training and Enrichment
- o Pet First Aid
- Fear Free Shelters reducing fear, anxiety and stress in shelter animals
- o Compassion Fatigue for Animal Care Professionals

Our dedicated WAG team members are leaders in advocating for humane animal welfare and leading the adoption of positive reinforcement training practices within our communities.

Relationships

• Over the years WAG has developed strong relationships with local veterinarians, force-free dog trainers, neighbouring animal shelters, and reputable dog walking and pet care professional

companies. This allows us to provide WAG animals with the best care possible as well as provide resources to community members including fosters, adopters and visitors.

• Over the past decade WAG has developed a positive working partnership with the Lil'wat Nation Community. This relationship allows us to work together to achieve our shared goal of reducing the stray animal population, reducing animal suffering and positively impacting the local health and safety for animals and human residents.

Community Love!

WAG has been a respected and loved community asset for over 40 years. We are honoured to have been voted once again the Favourite Whistler Non-Profit, 10 years in a row! The Whistler community loves WAG and the important work we do, we are grateful to be part of such a supportive community.

IMPLICATIONS: if FFS funding was <u>not</u> available, how would your organization provide the services indicated above; what aspects of those services would be most significantly impacted? **Maximum 250 words.**

WAG is committed to delivering life-saving services as an essential community resource. However, we currently face significant challenges in retaining and hiring skilled staff, which in turn is hindering our ability to provide all of our services and optimal care. Given these circumstances, we are seeking a Fee for Service increase in 2024.

The lack of pet-friendly housing in Whistler is a major factor contributing to pet surrenders. It's also causing difficulties in adopting or fostering as landlords impose restrictions, homes are sold, and the cost of rent increases. The capacity of shelters and rescue groups has been significantly strained, especially in the aftermath of the COVID pandemic and the substantial influx of surrendered animals.

Five years ago, all of our staff resided in Whistler. Today, however, only 50% of our staff are able to live in the area due to the high cost of living. Working for a non-profit in Whistler has become financially challenging, raising concerns about our sustainability to keep and maintain our staffing levels.

The impact of WAG's services extends significantly across the Whistler and surrounding communities including the Lil'wat Nation. As a provider of life-saving services throughout the Sea to Sky corridor, WAG's expertise in animal welfare plays a crucial role. WAG is regularly contacted by individuals and organizations for support.

If funding were not available:

- WAG would have to become more selective in animal intake. This would negatively affect animals brought in from neighboring areas, especially critical care and long-term behaviour cases. WAG often serves as a last hope for these animals and their caregivers, and without funding, euthanasia would become unavoidable for many.
- Our current team, which is already under significant pressure, would focus primarily on essential tasks like animal care, enrichment, adoptions, and surrenders on a limited basis. While basic adoptions and bylaw/impound services could continue, outreach efforts such as

animal wellness clinics, low-cost spay and neuter programs, and community events would be scaled back.

Without the support of FFS funding, the amount and type of animals WAG takes into our care would be at stake. In the absence of this funding, WAG could not maintain the staffing levels that are critical to keeping and maintaining the type and number of animals that WAG has had in our care over the years. This would negatively impact people in our community and neighbouring communities who need animal welfare support and assistance to surrender their animal.

For each animal we care for, we also touch the lives of 5-10 individuals. These include families facing challenges who seek a second chance for their pets, good Samaritans who bring injured animals to WAG, volunteers who find purpose and new skills in working with our animals, and the new families who adopt. WAG's impact extends not only to animals but also deeply enriches our human community.

We truly appreciate the ongoing support that RMOW has generously extended to WAG over the years. Thank you for taking our 2024 request into consideration.

We monitor the flow of animals through our organization that includes adoptions, surrenders, strays, and redemptions. WAG uses technology through the Shelter Buddy computer program which allows us to conduct year-to-year comparisons of animal statistics, while also keeping track of dog license sales, impounds, and fundraising totals.

In addition, WAG records data related to our low-cost spay and neuter surgeries, wellness clinic participation, and fundraising achievements. These details will be presented in our progress reports and year end presentation to Council.




LOLA - Available for Adoption

Our primary focus has always been on rehabilitating animals, both physically and emotionally. Many of the animals that find their way to WAG have endured trauma in their past.





Animal Wellness Clinics and Outreach

WAG holds Animal Wellness Clinic in the Lil'wat Nation community every summer. These clinics bring veterinary care to residents who may struggle with transportation or financial means for regular vet care of their beloved animals. We provide the community with vet exams, food, supplies, and vouchers for low cost spay and neuter surgeries.

Meet Hank. After an eye injury, his loving family needed help getting him to the vet, covering his medical bills, and understanding his aftercare. WAG was there every step of the way, supporting Hank's recovery. Today, Hank is thriving, showcasing the life-saving impact of the relationships we build at our wellness clinics.

Our core mission in action: Finding forever homes for our animals.


