A presentation was given by J. Hadley, BC Assessment Deputy Assessor, regarding 2024 BC Property Assessments.

5. PUBLIC COMMENT AND QUESTION PERIOD

Eric Callender, 8179 Meadow Lane

Mr. Callender opposed the adoption of the "Board of Variance Bylaw No. 2412, 2023" (BOV Bylaw) in tonight's agenda. Upon learning about the fee increase in the new BOV Bylaw through the Pique magazine article, Mr. Callender submitted a letter to the Council.

Mr. Callender acknowledged the excellent quality of staff reports, however Mr. Callender observed that staff reports can sometimes control the narrative. He raised concerns about potential biases in the staff report and questioned how the proposed changes to the BOV Bylaw would benefit the general public.

Mr. Callender posed a question to Council, asking for their opinion on whether the proposal complies with the affordability measures outlined in the Official Community Plan. Mr. Callender emphasized his belief that a flat fee increase (from \$800 to \$4,000) in such a short period is not affordable for the community.

Mr. Callender noted that in the same meeting, staff requested an amendment to the Building and Plumbing Fees bylaw with a 30 per cent increase across the board. He contrasted this with the application fees for the Board of Variance, which range between

\$3,000 to \$4,000. Mr. Callender expressed his concerns about these differences and urged the Council to consider the implications.

Dave Ashton, Rainbow neighbourhood

Mr. Ashton resides in one of Rainbow's senior buildings and recalls the excellent bus services provided by route #32. However, currently the only option available in his neighborhood is bus #10. The #10 service offers satisfactory morning service but it's not so reliable in the afternoon. This bus stop is inconveniently located and requires a lengthy walk to reach the lifts or other areas within the Village.

Mr. Ashton highlighted the impact of recent changes on commuting times, citing extended waits of up to 15 minutes from the Library stop when returning from the Village to Rainbow.

In contrast, he observed that Alpine Meadows benefits from the convenience of buses #33 and #31, with plans to add a third bus on Saturdays (bus #30). Meanwhile, the Cheakamus neighbourhood enjoys a variety of bus options, including numbers 20, 20X, 21, and 10.

Drawing attention to the unique needs of Rainbow, comprising two senior buildings, Mr. Ashton stressed that the sole bus servicing this community, bus number #10, has led to increased reliance on private cars due to recent schedule alterations.

Mr. Ashton urged staff to reinstate bus number #32 to Rainbow which would address the specific concerns of the senior community and enhance public transit accessibility in the area.
