<p>Coach Development \$5600</p> <p>Over the last 2 years, our program has made a major push at training more former athletes as coaches (they already have housing!) however, our 8 coaches who are Whistler-born are all Level 1 certified. Our goal is to have these athletes begin completing their Level 2 certification which allows them to coach inverts on skis.</p> <p>The grant money for this project would cover our Whistler-born and bred coaches (former WBFSC athletes) with subsidized access to complete their Freestyle Level 2 Certification. The full course is \$2800 with our club contributing 50% of the funds with 25% coming from the CEP grant.</p>
