**Tender Summary** 

As you are aware, tenders closed for the above contract on February 13, 2024 at 2:00 p.m. Two completed tenders were received and reviewed by ISL for accuracy (detailed summary attached). The tender values appear as below:

<u>Contractors:</u> <u>Tender price (exclusive of GST)</u>

Drake Excavating (2016) Ltd. \$1,849,500.00

Coast Mountain Excavations Ltd. \$1,199,690.00

The tenders and the values have been checked and are correct arithmetically for the amounts shown above.

The Engineer's Pre-Tender Estimate of Probable Construction Costs for this project was \$911,892.50 based on recent historical projects of similar scope and scale. In consultation with each of these Contractors after the tender closed, both Contractors pointed to significant risk associated with the geotechnical investigation along Taylor Way and Lake Placid Roads; the range of ground water fluctuation reported posed a risk of trench collapse and the Contractors were compelled to account for this risk with higher than usual unit rates. This elevated risk and the associated pricing appears warranted and as a result re-tendering is not likely to produce submissions with reduced costs.

The above tenders are in compliance with the Resort Municipality of Whistler's Instructions to Tenderers. Based on the above, we recommend awarding the contract to the low bidder, which in this case is Coast Mountain Excavations Ltd., for the amount of \$\$1,199,690.00, exclusive of GST.
