4. PUBLIC COMMENT AND QUESTION PERIOD

Eddie Dearden

Mr. Dearden asked why there are so many RMOW trucks with only one occupant driven around Whistler. Chief Administrative Officer G. Cullen responded that staff always try to carpool, but single-occupancy is the only option in some situations and that the organization is transitioning to alternative, non-fossil fuel trucks.

Mr. Dearden asked if Mayor and Council believe a resident needs a car to survive in Whistler. Mayor J. Crompton responded that it depends on each case, noting that more residents are using alternative ways of transportation like e-bikes and walking.

Mr. Dearden asked Mayor and Council to consider reducing the number of parking spaces when voting on future developments in Whistler and focus RMOW's efforts on improving public transit. Mayor J. Crompton responded that the best place to participate in the discussion about parking is during the upcoming Official Community Plan review process.
