The grant will be used to fund part of the payment for this year's Whistler Writer in Residence guest author and mentor, who will work closely with 10 local writers on their manuscripts, while working on their own creative writing project.

The author honorarium is \$6,000 for the two month-long program. This is the standard Writers Union of Canada fee. We kindly request the Community Enrichment Program (CEP) cover 50% (\$3,000) of the Writer in Residence honorarium fee. The Whistler Writing Society will take care of all other costs associated with the program, including the author's travel, administration, accommodation and promotion of the program.

The CEP grant is important to our local writers because it makes the program affordable to residents in the Sea to Sky Corridor. In addition, they do not have to travel to an urban centre to develop their craft and market-orient their work. In 2024, Writer in Residence Jennifer Manuel (The Morning Bell Brings the Brokenhearted) mentored participants of the program in-person in Whistler at The Point Artist's Cabin. We intend to run this year's program in a similar manner. Jen also taught a creative writing workshop at the Whistler Writers Festival, to make the most of her time here. The 2025 Writer in Residence author mentor is yet to be confirmed. Our shortlist of candidates includes the following award-winning Canadian authors; Billy-Ray Belcourt (This Wound is a World, Coexistence), Chelene Knight (Dear Currant Occupant, Junie), Lisa Moore (This is How We Love), Iona Whishaw (To Track A Traitor). This list of award-winning authors have attended our festival before. We strive to include and highlight BIPOC and LGBTQ2SI+ author/ mentors and participants to bring diverse experiences and perspectives to all our programming. Our writer in residence candidate list will expand as we understand the availability of these four author/mentor candidates.

This year, we will include a scholarship position for one of the 10 writer/participants. Our Amplifying Voices scholarship is dedicated to writers who are underrepresented in publishing (Indigenous, racialized, Deaf or hard of hearing, living with a disability, and/or LGBTQ2S+). Last year the scholarship went to a writer with a hearing disability.

No, the Whistler Writer in Residence program has been running annually since 2007.

3. Current Year Highlights and Community Benefits:

The two-month Writer in Residence features a Canadian award-winning author (TBC). This year's program will run from September through October. The author mentor will work with up to 10 fiction, creative non-fiction, young adult/children's, poetry writers and/or playwrights beginning in early September 2025.

The Whistler Writer in Residence provides three one-on-one writing critique feedback sessions and three group seminars on different aspects of writing craft, writing life and publishing industry. This type of intensive, craft-focused instruction is not available in Whistler except through this program. Many local writers have gone on from this program to form writing group connections with their program colleagues, and publish their manuscripts.

Example: This grant addresses the priority of "Community Engagement" because it strives to connect locals to each other. Specifically, this is because...

- 1. The Writer in Residence (WIR) program provides cultural enrichment and group learning opportunities for local resident writers in our own community, and increases access for residents to high-level Canadian authors and mentors. The mentor uses the cabin at The Point which is for artist-use only, so they don't displace any local residents from housing.
- The WIR program means that local writers don't have to travel to an urban centre to study the writing craft, thereby reducing emissions and protecting the environment. Our Society provides a bicycle to guest mentors to travel within Whistler.
- 3. The WIR fosters community engagement because participants meet other local writers forming valuable artist networks in our own community. Many WIR participants go on to publish their own books, enhancing the cultural experience and legacy of Whistler in our community. They also become featured writers at the Whistler Writers Festival, participating in their own book launches, presenting on panels and teaching workshops, to connect with local and visiting readers and writers.
- 4. The mentor resides at the cabin at the Point, drawing writers to a less busy part of Whistler. They contribute to local culture through their mentorship of local writers and the WIR participates/presents at the Whistler Writers Festival, which draws locals and visitors alike to the Whistler Writers Festival, to experience the arts in Whistler.

SUPPORT FOR TRUTH AND RECONCILIATION

The RMOW is committed to working with the Lílwat People, known in their language as L'il'wat7úl and the Squamish People, known in their language as the Skwxwú7mesh Úxwumixw to: create an enduring relationship; establish collaborative processes for planning on unceded territories, as currently managed by the provincial government; achieve mutual objectives; and enable participation in Whistler's resort economy.

9. How has your organization considered truth and reconciliation with the Indigenous Nations?

Our Society's programming has the potential to advance reconciliation and decolonization through including/ inviting Indigenous workshop leaders and storytellers as well as Indigenous participants.

We consult with Squamish Lil'wat Cultural Centre to understand cultural protocols, necessary and appropriate culturally-sensitive research, and network with Indigenous artists and organizations in our region. Through this relationship we have connected with both Lil'wat and Squamish Nation artists, included many in our events and programming, including sharing knowledge on artists' craft. We work directly with the artists involved in the workshops and oral storytelling events to ask how they would like to see them unfold, and how they would like to be represented.

For the last three years, we have offered opportunities to study the art and craft of oral storytelling from local Lil'wat and Squamish artists at the Whistler Writers Festival, bringing the art of Indigenous and cultural oral traditions to our audiences, opening the door to fruitful discussions on reconciliation and decolonization, both formally at events and between audience and workshop members helping them build their own personal 'back pocket reconciliation plans' (Chief Joseph, 2023).

In addition to local Indigenous participation, our festival typically has 6 Indigenous guest authors from across Canada participate in reading and workshop events. In 2024, we had moderators and MCs for all events read a short piece from an Indigenous author which was an enhancement to the festival's land acknowledgment.

At the submission of this application, we have invited Billy-Ray Belcourt, a writer and academic from the Driftpile Cree Nation to be our Writer in Residence. He is an Associate Professor in the School of Creative Writing at the University of British Columbia. He is the author of five books: This Wound is a World, NDN Coping Mechanisms: Notes from the Field, A History of My Brief Body, A Minor Chorus, and Coexistence.
