### BYLAW NOTICE ENFORCEMENT AMENDMENT BYLAW NO. 2269, 2020

#### A BYLAW TO AMEND “BYLAW NOTICE ENFORCEMENT BYLAW NO. 2174, 2018”.

---

**WHEREAS** the Council of the Resort Municipality of Whistler has adopted the “Bylaw Notice Enforcement Bylaw No. 2174, 2018”;

**AND WHEREAS** the Council of the Resort Municipality of Whistler deems it expedient to authorize the use of Bylaw Notices for the enforcement of certain bylaws, to designate expressions that may be used for certain bylaw offences and to set certain fine amounts;

**AND WHEREAS** the Council of the Resort Municipality of Whistler deems it necessary and expedient to amend the “Bylaw Notice Enforcement Bylaw No. 2174, 2018”;

**NOW THEREFORE** the Council of the Resort Municipality of Whistler, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. This Bylaw may be cited for all purposes as the “Bylaw Notice Enforcement Amendment Bylaw No. 2269, 2020”.
2. Bylaw Notice Enforcement Bylaw No. 2174, 2018 is amended by:
  - (a) adding the words “(50% of Penalty)” after the words “Compliance Agreement Available” in each heading under Column A4 in Schedule “A” of Bylaw Notice Enforcement Bylaw No. 2174, 2018;
  - (b) reorganizing the tables within Schedule “A” of Bylaw Notice Enforcement Bylaw No. 2174, 2018 in alphabetical order by title while retaining the complete column name at the top of each column;
  - (c) replacing the designated expressions for the following sections listed Column A1 of the table titled “Parking and Traffic Bylaw No. 2177, 2018” within Schedule “A” of “Bylaw Notice Enforcement Bylaw No. 2174, 2018” with the following designated expressions:

DESIGNATED EXPRESSION	SECTION(S)
Park in a restricted area	8.1 (h)
Licence plate not registered	8.1 (aa)
Fail to display valid parking coupon	8.1 (bb)
Park over 72 hr limit	8.1 (dd)
Park in accessible stall without permit	8.1 (ff)
Interfering with municipal services	8.1 (kk)

(d) adding the following line to the table titled "Parking and Traffic Bylaw No. 2177, 2018" within Schedule "A" of Bylaw Notice Enforcement Bylaw No. 2174, 2018 in numerical order by section number:
