## A BYLAW TO AMEND THE RESORT MUNICIPALITY OF WHISTLER LAND USE PROCEDURES AND FEES BYLAW NO. 2019, 2012

**WHEREAS** the Council of the Resort Municipality of Whistler may, by bylaw, impose application fees for an application to initiate the issuance of a permit under Part 14 of the Local Government Act or to use municipal property;

**NOW THEREFORE** the Council of the Resort Municipality of Whistler in open meeting assembled, **ENACTS AS FOLLOWS:** 

- 1. This Bylaw may be cited for all purposes as the "Land Use Procedures and Fees Amendment Bylaw (Temporary Outdoor Patios) No. 2286, 2020".
- 2. "Land Use Procedures and Fees Bylaw No. 2019, 2012" is amended as follows:
  - a) Section 4 is amended by adding the following in alphabetical order:
    - j. An outdoor patio licence.
    - k. Approval of outdoor patio on statutory right of way.
  - b) Schedule A is amended by deleting sections 6 and 7 and replacing these sections with the following:

6. temporary use permit	\$240
7. temporary use permit (renewal)	\$240

c) Schedule A is amended by adding the following in numerical order:

12. outdoor patio licence	\$240
13. approval of outdoor patio on statutory right of way	\$240

d) Schedule A is amended by adding in the paragraph below section 13 after the words "temporary use permit," the following:

"an outdoor patio licence and approval of an outdoor patio on a statutory right of way,"

e) Schedule A is amended by deleting in the paragraph below section 13 the following line:

"newspaper advertising

At cost"

f) Schedule A is amended by adding a second paragraph below section 13 as follows:

"Except for an application for an outdoor patio licence and approval of an outdoor patio on a statutory right of way, in addition to the above noted application fees, the following rate will be applied to all applications to cover the Municipality's direct costs related to the application:

newspaper advertising

At cost"

g) Schedule A is amended by adding a third paragraph below section 13 as follows:

Land Use Procedures and Fees Amendment Bylaw (Temporary Outdoor Patios) No. 2286, 2020 Page 2

"Despite the above application fees, where a temporary use permit and an outdoor patio licence or approval of an outdoor patio on a statutory right of way is required, the application fee for an outdoor patio licence or approval of an outdoor patio on a statutory right of way shall be waived."
