Due to an administrative error, the July 23, 2019 version of the OCP document included the incorrect version of the first map, titled Schedule A: Whistler Land Use Map and Designations. This Report requests that Council rescind third reading given on July 23, 2019 and that third reading be given to Official Community Plan Bylaw No. 2199, 2018, as further revised, with the correct version of Schedule A: Whistler Land Use Map and Designations.

#### DISCUSSION

Official Community Plan Bylaw No. 2199, 2018 was introduced to Council on October 2, 2018, at which time the bylaw was given first reading.

Official Community Plan Bylaw No. 2199, 2018, as revised was given second reading and authorization to proceed to Public Hearing on March 12, 2019. The Council resolution also included two additional revisions to Official Community Plan Bylaw No. 2199, 2018, as revised, the following of which is relevant to this Report:

On Schedule A Whistler Future Land Use Map and Designations change the designation for a portion of the lands located at 2501, 2505 and 2509 Gondola Way, PID: 006-984-801 District Lot 2291, Plan 19602 ("Bunbury lands"). Change the portion shown as Residential – Very Low, to Residential – Low to Medium;

A Public Hearing was held on April 16, 2019. The Public Hearing provided an opportunity for members of the public to make representations to Council or present written submissions respecting matters contained in the proposed bylaw and was conducted consistent with statutory requirements, including public notice requirements. The Public Hearing version of Official Community Plan Bylaw No. 2199, 2018, as revised, included the correct map that incorporated the change identified above. After the Public Hearing, staff did not recommend any changes to the map for Council's consideration of third reading of the OCP bylaw.

Official Community Plan Bylaw No. 2199, 2018, as further revised, was given third reading on July 23, 2019. Due to an administrative error, the version of the bylaw that was presented for third reading contained the incorrect version of Schedule A: Whistler Land Use Map and Designations. The map that was presented for the Public Hearing should have been the map that was included in the third reading version of Official Community Plan Bylaw No. 2199, 2018, as further revised.
