## OFFICIAL COMMUNITY PLAN BYLAW NO. 2199, 2018

## A BYLAW TO ADOPT AN OFFICIAL COMMUNITY PLAN

WHEREAS Council may, by bylaw, adopt an official community plan;

**AND WHEREAS** Council has directed the preparation of a new official community plan to replace the official community plan adopted in 1993;

**AND WHEREAS** the Council has considered the new official community plan in conjunction with the Resort Municipality's financial plan and liquid waste management plan and the Squamish Lillooet Regional District's solid waste and resource management plan;

**AND WHEREAS** the Council has considered the purposes and goals referred to in s. 428 of the *Local Government Act* to the extent that the new official community plan deals with those matters;

**AND WHEREAS** the Council has provided opportunities for consultation on the new official community plan with persons, organizations and authorities it considers will be affected, including the board of the Squamish Lillooet Regional District, the Lil'wat Nation and Squamish Nation, the Board of Education of School Districts No. 48 and No. 93, the provincial and federal governments and their agencies, and citizens of the Resort Municipality;

**AND WHEREAS** the Council has held a public hearing on the new official community plan on April 16, 2019;

**AND WHEREAS** the board of the Squamish Lillooet Regional District, by resolution dated October 23, 2019, accepted the regional context statement contained in the new official community plan;

**AND WHEREAS** the Minister of Municipal Affairs and Housing on June 16, 2020 approved the new official community plan pursuant to the *Resort Municipality of Whistler Act*;

**NOW THEREFORE** the Municipal Council of the Resort Municipality of Whistler, in open meeting assembled, enacts as follows:

- 1. The official community plan attached to this Bylaw as Schedule A is adopted as the official community plan of the Resort Municipality to replace the following:
  - a. the official community plan adopted by Bylaw No. 1021, 1993; and
  - b. any official community plan adopted by the board of the Squamish Lillooet Regional District, to the extent that the plan applied to land that is within the boundaries of the Resort Municipality.
- 2. This Bylaw may be cited as "Official Community Plan Bylaw No. 2199, 2018".

Given second reading, as revised, by a majority of all of the members of Council this 12th day of March, 2019.

Pursuant to Section 464 of the *Local Government Act*, a Public Hearing was held this 16th day of April, 2019.

Third reading rescinded by a majority of all of the members of Council this 9th day of June, 2020.

Third reading given, as further revised, by a majority of all of the members of Council this 9th day of June, 2020.
