> 2. I would like to see more legal art spaces or mural projects in Whistler. I have spoken to Arts Whistler, several businesses and community members who would like more public murals. They say that municipality is quite strict on public murals and it's hard to get them passed. I've moved here from a big city like a lot of others and a big reason for that is because of the outlets that Whistler offers.

> It's important that people of all ages have an area to express themselves creatively with visual arts. The skate park is very hard to paint and when trying to there is often conflict with skaters as we're in the way. This area would be ideal for a public legal wall though and would create a great backdrop to the parking lot.

The legal mural wall would also be a great place to host community art events and is in great proximity to The Audain and Maury Arts Centre. This will also give youth a place to further express themselves.

> 3.
