UPDATES

- Conservation Officer Service** A presentation by B. Mueller was given regarding Conservation Officer Service activities and a discussion was held.
- No bear calls in past month
 - Officer T. Shumacher has returned from parental leave
- Bylaw** A presentation by J. Pineda was given regarding Bylaw activities and a discussion was held.
- No calls for wildlife attractants in past month
- RMOW Environmental Stewardship** A presentation by H. Williamson was given regarding RMOW Environmental Stewardship activities and a discussion was held.
- L. Harrison has received Solid Waste Technician position with the RMOW Infrastructure Services Department and will not be returning as the Bear Smart Program Assistant.
 - The BSPA position has been posted with an April start date
- RMOW Communications Strategy** Committee reviewed the RMOW Bear Smart communications strategy and a discussion was held.
- Social Media
 - 2019 Review:
 - Bear related social media posts performed better than average in terms of the number of people reached and number of people interacting with posts
 - Wildlife alerts were best performing bear posts
 - Key messaging for 2020:
 - Call COS early- COS has many non-lethal tools to guide bears back to natural habitats before they become habituated.
 - Keep dogs on leash- Dogs do not provide protection from bears and even the most well trained dogs can provoke defensive behavior in a bear.
 - Manage attractants- everyone must remain diligent, it only takes one instance of a bear accessing a non-natural food source for them to develop an association between humans (Cars, BBQ's, etc.) and food
 - Give bears space- bears are wild animals and should be treated as such
 - Events
 - BSPA attended a large number of events in 2019 and spoke with many different demographics. However, young transient workers remain difficult to reach
 - Whistler Inside Scoop, occurs 2x per year, would be a great opportunity for BSPA to communicate bear messaging to young transient workers
 - Rental Properties
 - Ongoing issues with short term rental properties identified in 2019
 - Re-send rental 1-page document to all rental properties including Airbnb

- Include messaging alerting property owners that they could be fined if there are unsecured attractants on the property
- Bear viewing
 - Contact Hotel Association, Village Hosts and Tourism Whistler and encourage them to promote safe bear viewing practices:
 - Do not send visitors to specific locations to view bears on their own
 - If guests want to view bears then direct them to bear viewing tours
 - If you see a bear remain at least 100 meters away

**Bear Smart Door
Hangers and
Visitors Guide**

Committee reviewed the RMOW Bear Smart door hangers and visitors guides and a discussion was held.


- Small typo in "safe viewing of bears" section of visitors guide, ensure this is corrected for re-prints
- Reviewed both previous and new door hanger templates, decided that:
 - New templates are effective in delivering general information to homeowners
 - Old templates are more effective in alerting home owners to a potential issue on their property and would be more useful to COS. Some information on old templates is out of date.
 - If budget allows, update information in old templates and have both old and new versions of door hangers available. Alternatively, a new template could be designed which incorporates key aspects of previous designs.
- COS would like copies of visitors guide and door hangers
