**Re: UNDERGROUNDING OF OVERHEAD UTILITY SERVICES IN ALTA VISTA**

This letter indicates significant neighbourhood support for the application and cost analysis to bury overhead utility services, in concurrence with the RMOW water and sanitary services upgrade project.

We are requesting the municipality provide relevant information for a formal petition process that the property owners may consider the total cost of this work, minus any available grants.

**Background**

As the RMOW is undertaking a water, sewer and valley trail upgrade throughout the neighbourhood over the 2020 and 2021 construction seasons, this is a prime opportunity to have overhead utilities installed below ground. The benefits to undergrounding are not only aesthetic but it reduces maintenance costs, reduces storm damage and protects vital services in the case of wildfires.

There are approximately 145 properties in Alta Vista including 2 strata properties and 2 parks. We have made attempt to contact all property owners, without access to tax rolls or property owner information, which during Covid19 has been a daunting task. We have acquired over 138 contacts, including overwhelming verbal and email support for exploring the project feasibility, with only 2 negative responses received. To indicate the general support of the neighbourhood we provide the attached completed forms indicating owners names, signatures and addresses.

Under Section 212 of the Community Charter property owners within a defined area may 'petition' the municipality for local area service, for which the cost may be recovered as an add-on to annual property taxes over a number of years. For a petition to succeed for the whole of that area the petition must be signed by owners of at least 50% of the number of property parcels in the area and those must represent at least 50% of the assessed value of the properties. Should the petition succeed, services will be performed for all properties in the defined area and total cost shared among all property owners.

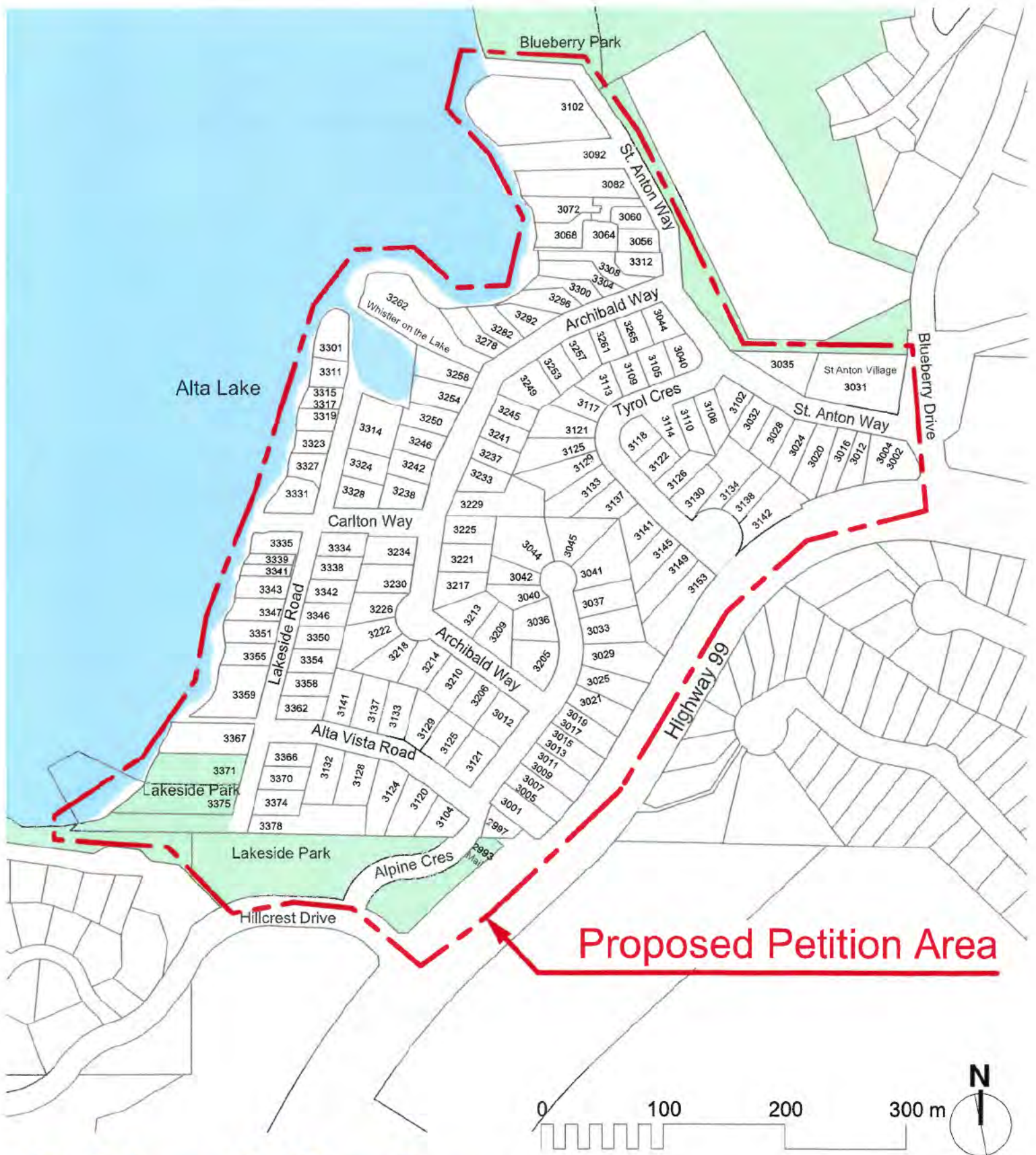
