Dear Council,
Please find enclosed a copy of the email I wrote to "Roads" way back when the signage changed to the current format.

*Good morning,
I hope the weekend went well with all the parking changes in effect.*

I chatted to Paul who was re signing Lake placid road last week, it is really good and so far this weekend the situation has been very much improved over previous weekends.

One thing to feedback, we as residents of the south end of lake placid road, ie between Taylor way and the turning circle by the valley trail have been left with no signage and a confusing situation.

We do not know if we are also no parking on one side of the street in line with the new rules in the rest of the Lake Placid Road, or as we suspect are we the Whistler standard of no parking on the odd side year round, (this makes more sense with the driveway spacing on that side)

If that is the case can we please ask that you bring back two of the signs that were removed!

ie the no parking odd and park even signs and put them either side of the street after Taylor way to clarify the situation and prevent us becoming the overspill parking area.

There are suitable poles in place and you have the signs so it's just a case of clamping them back on, I guess .

Lastly can you clarify if it is against the law or bylaw to park in the turning circle as this has never been confirmed and there is no signage to say otherwise, but cars get ticketed by bylaw.

Many thanks again for all the work your team has done on our street this week, it is very much appreciated.

Now just to clarify, this email was the first of three, and followed two voice

messages, all of which I received no reply to.

The Council should be congratulated on the speed and effectiveness of the introduction of the new parking arrangement, it works very well and is much safer.

The lack of signage at our end has meant that for the busier weekends there were cars parked randomly all over, at one time it was so tight an ambulance or fire truck would not of reached the turning circle due to cars being on both sides.

Please action the return of our two signs?
