New homes are being inhabited by full time residents and these people have come to Whistler and embraced our community and are actively supporting and engaged in our small town. Our neighbourhood is not them and us. It's a happy connected neighbourhood that supports each other and there was nothing to suggest angst over the decision that was fairly made.
