Dear Luce Wyn-Griffiths,

The Point Artist-Run Centre (PARC) would like to thank the RMOW for its 2020 Community Enrichment Program grant which supported PARC's continued operations under this year's challenging conditions, as well as the grant writing program to continue driving much-needed funds for future operations.

Twenty-five percent of this year's funds went to subsidizing PARC's Summer Events Assistant, [REDACTED]. In her second year at The Point, [REDACTED] was essential in keeping the children's and adult theatre and music programs as well as the Flag Stop Theatre & Arts Festival happening in a Covid-safe manner. She also helped to promote these programs through social media. Fifty percent of this year's CEP funds supported Artistic Director [REDACTED] for two months of the summer. Artistic Director fees are normally covered by funds generated through arts events, many of which were not able to be held this summer.

The final twenty-five percent of CEP funds went to PARC's grant writing program, hiring [REDACTED] to apply for a series of grants as well as spearhead a new fundraising initiative to replace the annual in-person fundraiser. Last year, the grant writing program resulted in a Canada Summer Jobs grant (over \$4000), a BC Arts Council grant of \$4500 for the Flag Stop Theatre & Arts Festival, a Community Foundation of Whistler grant of \$2750 for PARC's Artist Sessions program, and a \$900 Member Group grant from Arts Whistler for the Flag Stop Theatre & Arts Festival. The grant writing program carries into the winter with the aim of building greater capacity in the organization and increasing funding.

The Point Artist-Run Centre greatly appreciates the commitment of the RMOW in supporting PARC's operations in 2020, and in helping to build capacity in the organization to meet future challenges.
