In 2020, we had over 2,300 visits to our drop-in centres, provided 1:1 emotional support to 589 Women and 972 support calls, and supported 61 women and 23 children in our emergency housing for a total of 1,257 bed nights.

The PEACE (Prevention, Education, Advocacy, Counselling, and Empowerment) Program offers support and counselling services to children, youth and their families in Whistler and Pemberton who are experiencing conflict through abuse/violence in relationships and/or conflict through separation and divorce. The HSWC receives funding for 17.5 staff hours a week from the Ministry of Public Safety and Solicitor General for both communities. The program has been operating at 31 hours per week which includes 7.5 hours funded by community donations and 6 hours funded by the RMOW. However, due to increased need in the community, there is now an average waitlist of seven children. With increased funds from the Community Enrichment Grant, HSWC intend to increase the PEACE counselling hours to 35 hours per week in order to meet increased demand and mitigate the waitlist to effectively meet the growing needs of the children, youth and families within Whistler and Pemberton.

#### 3. Current Year Highlights and Community Benefits:

Last year (2020), the PEACE Program in Whistler/Pemberton supported 29 children and youth through 188 hours of individual counselling sessions, 72 hours of support groups, 13 kids through HSWC's summer camp program, 97 parent/caregiver support hours, and 32 family counselling hours. Through the PEACE program, children and youth learn how to identify hard to handle feelings and how to express them in healthy ways, recognize their strengths, and increase their self-confidence and self-esteem. They learn effective problem solving and coping skills, how to define and protect boundaries, how to keep themselves safe and to identify safe and supportive people in their life, and better understand the concept of healthy relationships. Most importantly, children are provided with a safe, supportive, nurturing environment to deal with traumatic events in their lives and learn that they are not alone and not at fault for the conflict/abuse they have witnessed and experienced. Parents are involved in the counselling process by learning skills and tools that will enable them to support their child/ren through difficulties associated with separation, divorce and gender-based violence.

If successful, HSWC will work towards eliminating the waitlist for PEACE counselling while supporting 40 to 60 children and 10 to 16 parents. If we not successful in receiving this grant, the PEACE program will have to cut back counselling hours which means we will not be able to support as many children, youth, and families. Many families seek HSWC services because it is free of charge and they cannot afford other options in the community that charge a fee for service. This means that families will have to wait on a waitlist until they can be seen.

Thank you for your continued support and we hope that you will consider supporting our essential community program again this year.

Enriching community life | This program directly improves the physical, mental, spiritual, and social well-being and health of children, youth and their families in Whistler. The program strives to keep children/youth healthy, safe, connected and active in the community. When children and youth have a safe, supportive place to talk about their feelings and learn ways of coping, they are less likely to engage in destructive, harmful, abusive behaviour, including using substances as they get older. We also know that when a child feels safe and supported, they have a better chance at succeeding in school, participating in community life, and striving for a better future for themselves. One day these children will grow up and be positive role models participating in Whistler community life. Parents/caregivers receive parent support around conflict/abuse and learn skills and tools so they can support their child/ren and build a safe connected family.

Ensuring economic viability | HSWC, through the Whistler Women's Centre, Safe Home, Transition House, Homeless Prevention Program, and PEACE programs offer survivors of gender-based violence and their children safe housing and ongoing support to give them the option to increase their safety and heal from violence and abuse while staying within their home community and maintaining their employment. By offering free, low barrier, non-judgmental, confidential support to all survivors in the community, the HSWC programs and services supports Whistler residents in continuing to engage fully in the economic, social, cultural, and recreational opportunities that make Whistler the vibrant community that it is. HSWC violence prevention efforts also contribute to long-term savings in community safety, crime prevention, and healthcare costs.

Partnering for success | Working collaboratively in partnership with other agencies, law enforcement, and the justice system is paramount to realizing the HSWC vision of a violence free future. With that in mind, WWC actively participates in cross-sectoral committees and partner relationships focused on ending gender-based violence, including RCMP, Victim Services, Ending Violence Association of BC, BC Society of Transition Houses, Sea to Sky Community Services, Mental Health and Addiction, the Ministry of Children and Family Development, and the Whistler Non-Profit Network. Specifically, within the PEACE program, the counsellors partner with schools and other organizations within Whistler to be able to effectively support more children and youth through support groups.

Behavioural problems such as aggression, withdrawal, poor social skills, adjustment difficulties, poor problem solving skills, and/or acting out.

Physical problems such as headaches, eating disorders, bed wetting, stomach aches, vomiting, nausea, and/or nervous tics.

#### THE GOALS OF THE COUNSELLING PROGRAM ARE:

- To provide a safe environment for children to talk about their feelings and help teach healthy ways to express them.
- To create an opportunity for children to deal with traumatic events in their lives.
- To enhance self-esteem and safety awareness issues.
- To promote effective problem solving and coping skills.
- To help children define and protect their personal boundaries.
- To help children understand that they are not alone and they are not at fault for traumatic events in their lives.
- To help children/youth to recognize their strengths and increase their self-confidence.
- To help children/youth to identify support networks

#### OTHER CHILDREN AND YOUTH PROGRAMS

GIRLS GROUPS: 8-10 week groups for girls ages 7-12. Groups focus on empowerment, building self-esteem, healthy communications, body image, boundaries and much more.

GIRLS SUMMER CAMPS: 5 day camps for girls ages 8-12, camps focus on selfexpression, community, nature, self-care, friendship and more.

#### YOUTH EDUCATION PROGRAM:

Educational presentations in schools that promote awareness and discussions around relationships. Topics include healthy/unhealthy relationships, bullying, violence in relationships, sexual exploitation, safety online, healthy communication, boundaries, where to get help and more.
