#1 Purpose of Grant

The purpose of the grant is to assist WYSC to cover a small amount of costs in order to keep soccer affordable for all its members.

Soccer is one of a very few team sports in our community and keeping it accessible to all is extremely important.

- 1/ Administration/Registrar Wages \$500 To assist in offsetting the wages of our manager/registrar. Covid safety protocols have required increased management to ensure all safety requirements and return to play protocols are being met.
- **2/ Technical Director/Wages** \$2500 To assist with off-setting some wages for our Head Coach and part time coaching staff who provide daily instruction during practices and games to our players and coaches to ensure that BC Soccer standards are upheld, and our players are getting the best experience possible
- **3/ Referee Fees \$1500** We encourage and support our youth by offering Referee Clinics annually and invest in their education to enhance their self-esteem when playing the game and enabling them to referee the game. This our existing youth referees will all be required to recertify their certifications in the Fall in order to referee our league home games.
- **4/ Uniforms for U15 Girls and U15 Boys** \$1000 We have not purchased uniforms for this age group in a couple of years. We were scheduled to purchase a set for them last season however, because of Covid and the abbreviated season we did not feel it necessary. This year they will need them.
- **5/ Preschool Soccer** \$500 In the Fall and Spring we offer a preschool soccer program to children ages 3-5years. The program runs once a week and requires 2 coaches to meet the required coach to player ratio under the current guidelines. The cost of the additional JR Coach will be covered by this grant.
- **6/ Kicking in Schools \$1000** We are programming as though we will be able to go ahead with this program as we will run it outdoors in the Fall. This program will operate at both Spring Creek and Myrtle Philip for children in grades kindergarten Grade 7. The program will run for 4 weeks outdoors with each player using their own ball. Whistler Youth Soccer Club works in partnership with the School and provides the equipment required.

This past year has highlighted the necessity of moving our bodies, connecting with people and being active.

For kids this has meant being able to participate in sport with peers.

Despite the many restrictions that come with participation and safe return to sport, Whistler Youth Soccer Club has been able to offer programming, both indoors and out, that was safe and fun for anyone who wanted to participate.

This past year also highlighted the importance that exercise plays in maintaining the mental wellbeing of our youth, furthering the important role youth sport plays in their wellness as a whole person during these always changing and often unknown times.

During a regular times, Whistler's love of soccer can be seen on the fields from the early Spring through the late Fall – from early morning on weekends until dusk three nights of the week. Our fields are bustling with players, coaches and parents keen to be part of and involved in 'the beautiful game'. Soccer is a sport that gets all walks of life in our community together and excited about physical activity and comradery.

It's also a sport that ensures that every child is able to play, regardless of skill level and/or financial support. On average the cost per child to participate in our program is \$2/hr. The grant money that we receive will help us maintain this pricing, allowing every child that wants to play the opportunity to play.

WYSC continues to strive to develop a passion for soccer (for life) by delivering quality affordable programs which enhance self-esteem and enrich the family community lifestyle which is a vital part of our community.

WYSC continues to have over 1/3 of Whistler school students participating proving our membership and coach involvement continue to be strong.

- 1/ WYSC has 15 volunteer coaches who dedicate many hours both on and off the field to our organization, giving them a sense of pride and contributing to and supporting our communities' children.
- 2/ WYSC provides local youth the opportunity to participate in low-cost, year-round sport that encourages and promotes a healthy life-style through exercise. Team play is a great social learning experience and fosters respect and develops a sense of belonging and self-esteem.
- 3/ WYSC strives to give back to the community wherever possible. We partner with the primary schools by providing low-cost soccer instruction as an alternative to gym classes (Kicking in Schools), which helps teachers learn new skills to use throughout the year. We aim to provide this again in the Fall and are prepared to do it with Covid restrictions or without.
- 4/WYSC continues to provide two \$500 scholarships to Whistler Secondary School each year to 1 male and 1 female graduate who has shown exceptional characteristics whilst being a member of our organization which is used towards post-secondary education.

5/ WYSC encourages older members to become qualified referees and supports and mentors them on the field. This helps them become confident in their capacity to referee and provides them with the opportunity to keep active and involved in the community whilst being paid.

6/ WYSC encourages and mentors older members to volunteer on field with younger players enabling them to complete required volunteer hours for school. It's also a great opportunity for all to experience new opportunities and be involved with various age groups within our community.

Ways to Improve on CPIs

WYSC strives to meet the needs of the community as well as accommodate our unique winter sport opportunities. We look for ways to make participating easy by removing barriers: This past season we changed our playing year to reflect our ski and snowboard season. By dividing our season into distinct playing blocks, we created registration options for everyone from the full season soccer player to the seasonal one we had playing options for everyone while maintaining our standard providing a place for everyone. We look for ways to develop physical literacy in our participants ensuring our players are well rounded, capable and confident athletes whose love and ability to participate are established for life.

WYSC is looking at ways to provide soccer for our older athletes as they age out or chose not to continue playing in a competitive manner. We are trying a COED league to provide a fun and athletic option to our athletes looking for an easy and fun option.

As well this year, we are looking at offering a one-day tournament that will host younger players for a one day tournament to offer another competitive friendly opportunity for our players.

Finally, we are striving to offer the Kicking in Schools to both Myrtle Philip and Spring Creek Elementary School this year. Offering this program in both schools, will include more of our community's youth as well as their teachers the opportunity to enhance their school day experience. We believe that meeting kids at their school takes away barriers to participation while developing the teacher's competence to coach soccer.




