<p>1. Whistler Gymnastics is requesting funding for the purchase of four tablets and accessories. Each Tablet will hold program specific software to allow our programmers to move to digital attendance, reports, newsletters, certificates and progress reports. This will also allow us to share digital recordings of individual athletes for parental viewing during Covid restrictions. We requested funding for this move to digital last year, however were gratefully permitted to use the funds instead for crucial Covid supplies. The cost for four Tablets is \$2000, Cases \$200, Bluetooth adapter \$125. Total funding request \$2325.</p> <p>2. Coach Development- Trampoline. Recent insurance changes mandate that all our trampoline coaches meet and maintain new certification requirements. This is ongoing and required in all programs including special programming such as parlour and freestyle trampoline. Due to Covid restrictions our coaches cannot travel to other regions so we are required to bring a trainer in-house. The funding request for Trampoline certification is \$1200.</p> <p>3. Coach Development- Active Start. The Canadian Long Term Athlete Development plan encourages Active Start programs as a pathway to physical literacy. This group includes those age 1-5 and is currently the area of most rapid growth. There have been large waitlists for this program recently and we would like have more coaches certified in order to better service this area of the community. This training also is currently required to be in-house. The funding request for Active Start certification is \$1200.</p>

<p>Not new programs-the tablets and coach development will aid in our expanding programs. Currently, we do our attendance, certificates, newsletters, progress reports all on paper. We would like to go as paperless as possible.</p>
