A BYLAW TO AMEND A HOUSING AGREEMENT

WHEREAS the Municipality is the registered owner in fee simple of LOTS 1, 2, 3, 4, 5, and 6 DISTRICT LOT 8073 GROUP 1 NEW WESTMINSTER DISTRICT PLAN EPP111931 (the "Lands") which parcels of land are proposed to be created by subdivision of BLOCK A DISTRICT LOT 8073 GROUP 1 NEW WESTMINSTER DISTRICT ("Block A") and are shown on the proposed plan of subdivision attached to this Bylaw as Schedule A;

AND WHEREAS subject to the terms and limitations in a Declaration of Bare Trust and Agency Agreement dated October 15, 2008, the Lands are held by the Municipality in trust for Whistler 2020 Development Corp. ("WDC"), a company wholly-owned by the Municipality;

AND WHEREAS the Municipality entered into an affordable employee housing agreement in respect of Block A, as authorized by Resort Municipality of Whistler Housing Agreement Bylaw (Cheakamus Crossing Phase 2) No. 2312, 2021 (the "Block A Housing Agreement") and the housing agreement was registered in the Land Title Office as a covenant under s. 219 of the *Land Title Act* on April 16, 2021 under No. CA8925452;

AND WHEREAS proposed LOT 4 DISTRICT LOT 8073 GROUP 1 NEW WESTMINSTER DISTRICT PLAN EPP111931 ("Lot 4") is designated for market housing as permitted by the Community Land Bank Agreement between the Province of British Columbia and the Municipality pursuant to which the Province transferred Block A to the Municipality, and the Municipality accordingly wishes to exclude Lot 4 from the terms of the Block A Housing Agreement;

NOW THEREFORE the Council of the Resort Municipality of Whistler, in open meeting assembled, **ENACTS AS FOLLOWS**:
