An update by J. Pineda was provided on behalf of RMOW Bylaw Services

- No COS reports had been forwarded to Bylaw Services
- No bear incidents or attractants to attend to

An update by A DeJong, was given regarding bear activity at WB:

Very low bear activity/movement and no incidents on WB

Tara mentioned that it has also been quiet for the RMOW regarding bear related issues except for the 2 recent reports: 1 bear bluff charging at Fitz Nature Trail and the other bear at Lost Lake Park attempting to access food. The topic of drought and berries came up as it may be a poor berry season due to the hot and dry conditions which may provoke more bear incidents moving into the Fall.

An update by J.Kozikowska, was given on RMOW's bear smart program

No bear incident reports other than the 2 recent ones that Tara mentioned. The one bear on the Fitz Nature Trail has bluff charged people using the trail. This is a tagged bear. The other bear was at Lost Lake Park during a busy morning attempting to access peopl'e food without any fear. COS was called but no one showed up. In the end the RCMP showed up but the bear had left the Parl area and had moved on. Good idea to reach out to COS to see if there is a better way to communicate in this type of circumstance so that they could respond.

An update by I. Minic-Lukac was given on behalf of the WWPG

- Biking for bears event occurred
- Golf courses were extremely busy this spring
- Conducted door to door education at Alpine and Emerald neighborhoods. Received more door hangers so has enough supply for now
- Asked if the group could get a copy of the annual COS Report to the RMOW so that they could access stats regarding bears
